E.I. Sturdza Strategic Europe Value Fund (the "Fund")

A sub-fund of E.I. Sturdza Funds plc ("the UCITS") managed by E.I. Sturdza Strategic Management Limited. EUR Institutional Share Class ISIN: IE00B7TRTL43 (the "Representative Class").

INVESTMENT OBJECTIVE & POLICY

The investment objective of the Fund is to achieve long term capital growth, by investing primarily in equities or other asset classes representing the return of equity securities listed on exchanges within Europe, although a maximum of 25% of assets can be invested outside of Europe.

The Fund expects to invest in a concentrated portfolio of between 25-35 individual securities, which will primarily be listed on a Recognised Stock Exchange targeting underlying investments that can easily be bought or sold in the market with few liquidity constraints.

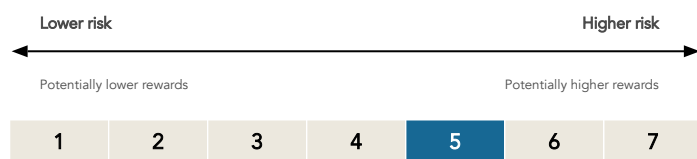
The Fund may use financial derivatives such as futures and options both to hedge the value of the assets within the

investment portfolio or to gain additional investment. It is therefore possible that a large proportion of the Fund's assets may be invested in financial derivative instruments at any one time which may enhance or detract from the performance of the Fund.

The performance of the Fund is measured against the MSCI Europe Net Total Return Index.

This Fund is deemed appropriate for investors who plan to invest with a medium to long view.

RISK & REWARD PROFILE OF THE FUND



The risk indicator is based on historical data and may not be a reliable indicator of the future risk profile of the Fund, is not guaranteed and may change over time. The lowest category does not mean risk free.

The risk indicator for the Fund is set as 5, which reflects the historic price behaviour of the Fund. Factors that affect the indicator include:

Investments in equity securities are subject to fluctuations in value dependent on market conditions which will directly affect the value of investments held by the Fund.

The Fund invests with a focus on one region which may increase the risk of investing when compared to a fund that invests in a globally diversified range of countries.

The Fund invests in a concentrated portfolio of investments that may potentially focus on one or more sectors or industries. The range of investments may increase the risk profile of the Fund compared to a more diversified portfolio across sectors and industries.

Additional risks of investing in this Fund include:

Currency Risk: the risk that changes in the exchange rates of the currencies of the investments in which the Fund invests may adversely impact the value of the investments held by the Fund.

Custody and Settlement Risk: the risk that the transactions entered into by the Fund are not settled or registered as appropriate.

Financial Derivatives Risk: the risk that financial derivatives may increase or reduce exposure to underlying assets and may create gearing; therefore their use may result in greater fluctuations of the Net Asset Value of the Fund.

Liquidity Risk: the risk that the assets of the Fund may have low levels of liquidity in some circumstances.

Operational Risk: the risks associated with correctly reflecting the value and safekeeping of the assets of the Fund.

Taxation Risk: the risk of changes in taxation regimes, including legal and regulatory changes.

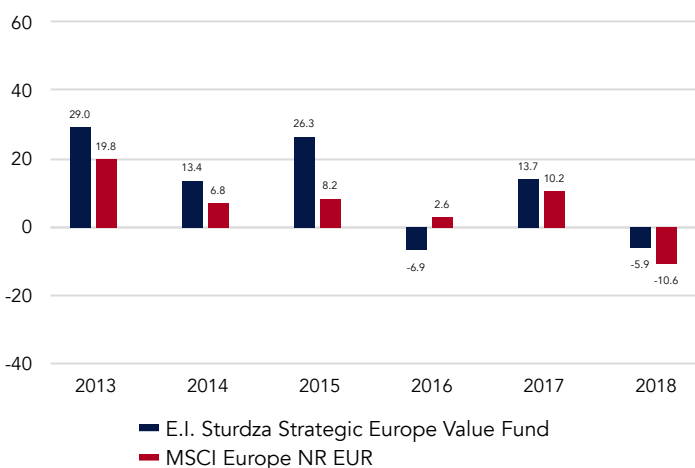
The entry and exit charges shown are maximum figures and include a provision for an anti dilution levy. An anti-dilution levy may be applied at a maximum rate of 0.15% of the value of each trade. These charges represent the amount that might be taken out of your money before it is invested or before the proceeds of your investment are paid out. Such charges are used to pay the costs of running the Fund, including the costs of marketing and selling. Overall, these charges reduce the potential growth of your investment.

In some cases you might pay less entry and exit charges. Please refer to your financial adviser or the Distributor for the actual entry and exit charges.

The ongoing charge is based on estimated fees and expenses that the Representative Class will pay in one year. This figure may vary from year to year. It excludes performance fees and portfolio transaction costs, except in the case of an entry / exit charge paid by the Fund when buying or selling units in another collective investment undertaking.
