
## **INVESTMENT OBJECTIVE & POLICY**

The investment objective of the Fund is to achieve long term capital growth, by investing primarily in equities or other asset classes representing the return of equity securities listed on exchanges within Europe, although a maximum of 25% of assets can be invested outside of Europe.

The Fund expects to invest in a concentrated portfolio of between 25-35 individual securities, which will primarily be listed on a Recognised Stock Exchange targeting underlying investments that can easily be bought or sold in the market with few liquidity constraints.

The Fund may use financial derivatives such as futures and options both to hedge the value of the assets within the

The performance of the Fund is measured against the MSCI Europe Net Total Return Index.

This Fund is deemed appropriate for investors who plan to invest with a medium to long view.

Additional risks of investing in this Fund include:

Currency Risk: the risk that changes in the exchange rates of the currencies of the investments in which the Fund invests may adversely impact the value of the investments held by the Fund.


The entry and exit charges shown are maximum figures and include a provision for an anti dilution levy. An anti-dilution levy may be applied at a maximum rate of 0.15% of the value of each trade. These charges represent the amount that might be taken out of your money before it is invested or before the proceeds of your investment are paid out. Such charges are used to pay the costs of running the Fund, including the costs of marketing and selling. Overall, these charges reduce the potential growth of your investment.

In some cases you might pay less entry and exit charges. Please refer to your financial adviser or the Distributor for the actual entry and exit charges.

The ongoing charge is based on estimated fees and expenses that the Representative Class will pay in one year. This figure may vary from year to year. It excludes performance fees and portfolio transaction costs, except in the case of an entry / exit charge paid by the Fund when buying or selling units in another collective investment undertaking.
