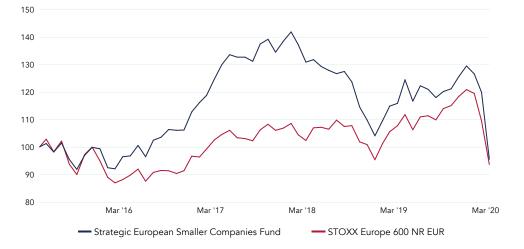
#### **INVESTMENT APPROACH**

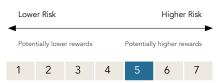
