
INVESTMENT OBJECTIVE & POLICY

The investment objective of the Fund is to achieve long term capital growth by investing primarily in equities or other asset classes representing the return of equity securities listed on exchanges globally. Investment will normally be concentrated in a portfolio of 20-30 individual securities and will emphasise investment in global companies that have a minimum market capitalization of USD 1 billion. Investment in emerging markets, to include Russia, will be limited to 25% of assets.

The Fund's investments will be primarily listed on a Recognised Stock Exchange and the Fund will target underlying investments that can easily be bought or sold in the market with few liquidity constraints.

The Fund may use financial derivatives such as futures and options both to hedge the value of the assets within the investment portfolio or to gain additional investment exposure. It is therefore possible that a proportion of the Fund's assets may be invested in financial derivative instruments at any one time

The Fund is actively managed, with reference to the MSCI World NR USD Index (the "Index") for performance monitoring and calculation of performance fees. The Investment Adviser is not subject to constraints in terms of deviation from the benchmark composition and may use its discretion to invest in securities/ sectors which are not included in the Index. The degree of freedom from the Index may potentially be significant.

You can buy and sell your shares in the Fund on a daily basis. The Shares that you will hold in the Fund are accumulating, meaning that the income from the Fund's investments will be included in the value of your shares rather than being paid as a dividend.

This Fund is deemed appropriate for investors who plan to invest for the medium to long term.

Additional risks of investing in this Fund include:

Currency Risk: the risk that changes in the exchange rates of the currencies of the investments in which the Fund invests may adversely impact the value of the investments held by the Fund.

Custody and Settlement Risk: the risk that the transactions entered into by the Fund are not settled or registered as appropriate.
